- The vehicle must have equal or less than two axles, six tires and a total weight of 19,500 pounds.

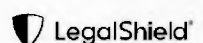

Home Business Supplement

Advice, Consultation and Research

Advice and consultation on any legal matter related to your home business, plus research.¹

Document Review

Up to 4 legal documents per month, up to 25 pages each. Additional document review of 25 pages or less can be provided for a flat rate of \$75 each document.

Letters and Phone Calls

Up to 12 letters or phone calls per year with 1 follow-up letter per matter. Additional communications available for a flat rate of \$75 each.

Designated Consultation

3 annual 30-minute designated phone consultations for business legal matters related to tax, patent, trademark, copyright, or antitrust.

Collection Letters

Receive 4 collection letters per month from your provider law firm. Additional collection letters per month available at a flat rate of \$75 each letter.

IRS Audit Legal Services

Legal assistance for items included on Schedules C and E of your personal federal income tax return.

- If the business entity is for residential properties, the owner may not have more than 10 units/leases.

³Covered lawsuit is a criminal or civil lawsuit arising from a firearm incident involving a covered person where the covered person is legally permitted to possess and carry (concealed or open) his/her firearm. Appeals of a trial court's decision, preexisting conditions, lawsuits involving the use of a firearm (including a firearm incident in the commission of a crime), on-duty law officers, and/or security officers are not included.
